#### 4. ELIGIBILITY CONDITIONS

- 1. Local Status: Must be a *local resident of Andhra Pradesh*. (The Definition of Local Candidate is enclosed as Annexure-I of this Notification)
- 2. Age Limit:
  - Minimum: 18 years as on 01-05-2025
  - Maximum: 50 years as on 01-05-2025
     (Age will be verified as per SSC certificate only)
- 3. Gender: Both Male and Female candidates are eligible.
- 4. Educational Qualification:
  - Must have passed Intermediate (10+2) or equivalent from a recognized board.
- 5. Technical Requirements:
  - Must have good Computer Knowledge (MS Office, Internet, Typing, etc.)

#### 6. Driving License:

o Must possess a valid Driving License (LMV or HMV).

#### 7. Physical Standards:

- o Height: Men should be 160 cm.
- Height: Women: 150 cm (Relaxation of 5 cms in case of STs only).

#### 8. Character and Antecedents:

 Should have satisfactory antecedents; will be verified by the Police Department.

#### 9. Medical Fitness:

Must be physically and mentally fit.

Preference will be given to candidates possessing:

Applications will be screened for eligibility criteria.

- All original documents will be verified.
- Failure to produce required documents will lead to disqualification.

#### c. Physical Measurement Test (PMT)

- Male: Minimum 160 cm
- Female: Minimum 150 cm (ST women: 145 cm)
  - o Candidates below the required height will be disqualified.

#### d. Skill Test

- <u>Computer Knowledge Test:</u> Proficiency in MS Office, Internet browsing, other computer applications, Typing, Drafting Skills, etc.
- <u>Driving Test:</u> Practical driving test.

- 2. Candidates are advised to ensure eligibility before applying.
- 3. No TA/DA will be provided for attending the selection process.

#### **ANNEXURE-I**

#### **DEFINITION OF LOCAL CANDIDATE:**

- (i) "Local Candidate" means a candidate for direct recruitment to any post in relation to that Local area where he/she has studied in Educational Institution(s) for not less than four consecutive academic years prior to and including the year in which he/she appeared for SSC or its equivalent examination. If however, he/she has not studied in any educational institution during the above four years period, it is enough if her/she has resided in that area which is claimed as his/her local area during the above said period.
- (ii) In case the candidate does not fall within the scope of the above it will be considered if he/she has studied for a period of not less than seven years prior to and inclusive of the year in which he/she has studied for the maximum period out of the said period of seven years and where the period of his/her study in two or more local areas are equal, such local area where he/she has studied last (in such local area) will be taken for determining the local candidature. Similarly, if he/she has not studied during the above said period in any Educational Institution(s), the place of residence during the above period will be taken into consideration and local candidature determined with the reference to the maximum period of residence or in the case of equal period where he/she has resided last.
- (iii) If the claim for local candidature is based on study, the candidate is required to produce a certificate from the Educational Institution (s) where he /she has studied during the said 4 years period, i.e., from VII class to X class (or) 7 years period i.e., from IV class to X class, in case he/she has not studied from VII class to X class in one particular district in Annexure I (A). If however, it is based on residence, a certificate should be submitted as prescribed in Annexure I (B) obtained from an officer of the Revenue Department not below the rank of a Mandal Revenue Officer in independent charge of a Mandal.

**NOTE:** Single certificate, whether of study or residence would suffice for enabling the candidate to apply as a "Local Candidate".

(iv) If, however, a candidate has resided in more than one Mandal during the relevant four/seven years period but within the same District, separate certificates from the Mandal Revenue Officers exercising jurisdiction has to be obtained in respect of different areas.

**NOTE:** Residence certificate will not be accepted, if a candidate has studied in any educational institution upto SSC or equivalent examination. Invariably, such candidates have to produce study certificates only. The candidates, who acquired Degree from Open Universities without studying SSC/Matriculation or equivalent in educational institution, have to submit residence certificate only.

Reservation to local candidates is applicable as provided in the Rules and as amended from time to time as in force on the date of notification. The candidates claiming reservation as local candidates should enclose the required Study certificates (from VII class to X class (or) from IV class to X class, in case he/she has not studied from VII class to X class in one particular district). Residence Certificate in the given proforma only should be enclosed for those candidates who have not studied in any Educational Institutions.

**NOTE:**As per G.S.R. 775 (E) read with GSR 591 (E): The candidates who migrated to any part of the State of Andhra Pradesh from the State of Telangana within a period of ten years from the 2<sup>nd</sup> day of June, 2014 shall be regarded as the local candidate in the State of Andhra Pradesh at the place of his / her residence and be treated at par with the local candidates residing in that area, in accordance with such guidelines as may be issued by the Government of Andhra Pradesh for the purpose of employment.

Candidates who are covered by this order will be required to submit necessary certificate as per the instructions given by the Government of Andhra Pradesh at the time of appearing for Physical Measurement Test and Physical Efficiency Test (Only those candidates who qualify for Preliminary Written Test).
